**1. Eligibility:** Faces of Eastern New York (the “contest”) is only open to registered members of Eastern New York Youth Soccer Association. Members under the age of 13 must have permission to participate from a parent or guardian. Void where prohibited. The contest is only open to legal residents of United States of America and is void where prohibited by law. B. Entries will be reviewed by Eastern New York Youth Soccer Association during the first week of the contest (March 28, 2016- April 3, 2016). If a person’s identity is exposed in a photo, said photo will be disqualified from the contest. Photos with a low resolution will also be disqualified. During the second week of the contest (April 4, 2016- April 10, 2016), Eastern New York Youth Soccer Association will post remaining photos on Facebook, Twitter, and Instagram where “followers” will vote for their favorite photos by “liking” or “commenting” on them. The top 10 photos will be selected by the most votes (“likes” and “comments”) received.

C. The entry must fulfill all contest requirements, as specified, to be eligible to win. Entries that are not complete or do not adhere to the rules or specifications may be disqualified at the sole discretion of Eastern New York Youth Soccer Association. Participants may enter as many times possible on Facebook, Twitter, and/or Instagram. "Top 10" winners must sign a photo release in order to be included in the Eastern New York Youth Soccer Association app. Eastern New York Youth Soccer Association shall have no liability for a winner's failure to receive notices due to winners' spam, junk e-mail or other security settings or for winners' provision of incorrect or otherwise non-functioning contact information. If the selected winner cannot be contacted, is ineligible, fails to claim the prize within 15 days from the time award notification was sent, or fails to timely return a completed and executed declaration and releases as required, prize may be forfeited and an alternate winner selected.
