



2018 CLUB PASS FAQ's

Teams participating in the **2018 US Youth Soccer national competitions (i.e. Presidents Cup and State Cup)** will be allowed to utilize the Club Pass System. Each team is responsible for providing the required information on properly registered STYSA players who they wish to Club Pass to their team for this competition. All requests for a team must be submitted through the Club Pass Request Form and must include all required information about the player. If you need an ID number or date of birth, please contact the player or the Club Registrar. Remember, the player must be properly registered with South Texas Youth Soccer Association and with the same club with which the team is registered and participating.

Following are answers to questions that have been asked about the process:

Q: Can a player on a State Cup (National Cup) team not advancing to the State Cup Club Pass to an advancing State Cup team?

A: Yes, as long as the player is properly registered with STYSA and with the same club as the advancing team.

Q: Can a player on a State Cup team advancing to the State Cup Club Pass to another advancing State Cup team?

A: No, a player may not club pass to another team in the same Cup competition until their current team has been eliminated from that competition.

Q: Can a player on a State Cup team Club Pass to a Presidents Cup team?

A: No, a player may only Club Pass in the same or to a higher level Cup competition.

Q: Can a player that played in the Southern Regional Premier League in Fall 2017 or Spring 2018 Club Pass to a Presidents Cup team?

A: No, a player who played in the Southern Regional Premier League are not eligible to participate in the Presidents Cup competition.

Q: Can a player on a Presidents Cup team not advancing to the State Finals Weekend Club Pass to an advancing Presidents Cup team?

A: Yes, as long as the player is properly registered with STYSA and with the same club as the advancing team.

Q: Can a player on a Presidents Cup team advancing to the State Finals Weekend Club Pass to another advancing Presidents Cup team?

A: No, a player may not club pass to another team in the same Cup competition until their current team has been eliminated from that competition.

Q: Can a player on a Presidents Cup team advancing to the State Finals Weekend Club Pass to a State Cup team advancing to the State Cup Finals Weekend?

A: Yes, as long as the player is properly registered with STYSA and with the same club as the advancing team. Once the player Club Passes to the State Cup team, they can no longer participate in the Presidents Cup event.

- Q: Can a player on a Presidents Cup team advancing to the Regional Competition Club Pass to a State Cup team advancing to the State Cup Finals Weekend?
- A: No, a player may not club pass to a team in another Cup competition until their current team has been eliminated from the competition they are participating in.
- Q: Can a player on a Directors Cup team Club Pass to a team advancing to either the Presidents Cup State Tournament or the National Championship State Cup?
- A: Yes, as long as the player is properly registered with STYSA and with the same club as the team.
- Q: Can a player on a South Texas Cup team Club Pass to a team advancing to the Presidents Cup State Tournament or the National Championship State Cup?
- A: Yes, as long as the player is properly registered with STYSA and with the same club as the team.
- Q: What is the limit on the number of Club Passes a team can use?
- A: There is no limit; however, the team must retain their roster consistency of 9 players from the roster freeze date and remain within the allowed roster limit (11U-12U: 16 Players. 13U-15U: 18 Players. 16U-19U: 22 Players).
- Q: Can a team replace a rostered player with a Club Pass player?
- A: Yes, as long as the team retains the roster consistency of 9 players. A player who will not be participating with the team in the State Tournament may be removed from the Game Day roster but will remain officially rostered to the team.
